Important Questions	Answers	Why this Matters:
What is the overall <u>deductible</u> ?	\$0 at Indian Health Care <b>Provider</b> (IHCP) or with IHCP <b>referral</b> at non-IHCP; \$2,900 person/ \$5,800 family	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u>
Are there services covered before you meet your <u>deductible</u> ?	Preventive services, maternity office visits (1-15 per year)	This <u>plan</u> covers some items and services even if you haven't yet met the annual <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain preventative services without <u>cost sharing</u> and before you meet your <u>deductible</u> . Are there other <u>deductibles</u> for specific services? What is the <u>out-of-pocket limit</u> for this plan?	\$8,700 person/ \$17,400 family;	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this <u>plan</u> they have to meet their own out-of-pocket limits until the overall family <u>out-of-pocket limit</u> has been met
What is not included in the <u>out-of-pocket limit</u> ?	Premiums, balance billed charges, non-covered services.	Even though you pay these expenses, they don't count toward the out-of-pocket limit
Will you pay less if you use a <u>network provider</u> ?	Yes. See <a href="https://hf.org/MP_directory_2023">https://hf.org/MP_directory_2023</a> or call 1.855.443.4735 for a list of <u>network</u> providers.	This <u>plan</u> uses a provider <u>network</u> . You will pay less if you use a <u>provider</u> in the <u>plan's network</u> . You will pay the most if you use an out-of- <u>network</u> provider, and you might receive a bill from a <u>provider</u> for the difference between the <u>provider's</u> charge and what your <u>plan</u> pays (a <u>balance billing</u> ). Be aware your <u>network</u> provider might use an out-of- <u>network</u> provider for some services (such as lab work). Check with your <u>provider</u> before you get services.

**About these Coverage Examples:**



**This is not a cost estimator.** Treatments shown are just examples of how this **plan** might cover medical care. Your actual costs will be different depending on the actual care you receive, the prices your **providers** charge, and many other factors. Focus on the cost sharing amounts ( **deductibles** , **copayments** and **coinsurance** ) and excluded services under the plan. Use this information to compare the portion of costs you might pay under different health plans. Please note these coverage examples are based on self-only coverage.

**Peg is Having a Baby**

(9 months of in-network pre-natal care and a hospital delivery)

- The **plan's** overall **deductible** \$2,900
- **Specialist** copayment \$30
- Hospital (facility) coinsurance 20%
- Other **coinsurance** coinsurance 20%

**This EXAMPLE event includes services like:**

- **Specialist** office visits ( prenatal care)
- Childbirth/Delivery Professional Services
- Childbirth/Delivery Facility Services
- **Diagnostic tests** ( ultrasounds and blood work)
- **Specialist** visit (anesthesia)

**This EXAMPLE event includes services like:**

- **Primary care physician** office visits (including disease education)
- **Diagnostic tests** (blood work)
- **Prescription drugs**
- **Durable medical equipment** (glucose meter)

**Total Example Cost** \$5,600

(in-network emergency room visit and follow up care)

- The **plan's** overall **deductible** \$2,900
- **Specialist** copayment \$30
- Hospital (facility) coinsurance 20%
- Other **coinsurance** coinsurance 20%

**This EXAMPLE event includes services like:**

- **Emergency room care** (including medical supplies)
- **Diagnostic test** (x-ray)
- **Durable medical equipment** (crutches)
- **Rehabilitation services** (physical therapy)

**Total Example Cost** \$2,800

**In this example, Mia would pay:**
